### **Maharashtra Value Added Tax Act, 2002.**

No. Jt.C(HQ)1/VAT/2005/154. - In exercise of the powers conferred by sub-section (3) of section 10 of the Maharashtra Value Added Tax Act, 2002, (Mah.IX of 2005), the Commissioner of Sales Tax, Maharashtra State, Mumbai hereby, specifies the areas mentioned in column (3) of the Schedule appended hereto, to be areas over which the officers for the time being holding the respective posts specified in column (2) of the said Schedule, shall have jurisdiction.
